

FEE SCHEDULE -- Effective January 1, 2026

CDD FEES & POLICIES

Policies Applicable to All Fees & All Divisions of CDD

All required fees must be submitted at the time of application.

Penalty fees in addition to the normal permit fees will be double the normal fee for applications submitted after construction has been initiated or written enforcement action has commenced.

Additional fees shall be paid as directed by the Community Development Director/Land Use Administrator (LUA), if review time exceeds fees by 50 percent or more.

In addition to the normal permit fees, if Community Development Department staff determine it is necessary for experts, contracted by the County, to assist in application reviews and/or project management of stormwater & erosion control plans and installations, conditional/land use permits, and enforcement matters, such additional costs shall be paid by the applicant(s) and/or property owner(s). Community Development staff shall work with appropriate experts to receive an estimate for services prior to requiring/receiving the fee from the applicant(s) and/or property owner(s).

All fees are represented as cash in this fee schedule and are non-refundable, unless approved by department administrator or director.
