Stat. § 19.84, the Election Inspectors at each polling place will convene as the Local Canvassing Board for the purpose of conducting the local canvass pursuant to Wis. Stat. § 7.51. This meeting will be open to the public pursuant to Wis. Stat. §§ 19.81-89.

****Notice of Meeting of the Local and Municipal Board of Canvassers**

At the close of voting on Election Day, pursuant to the provisions of Wis. Stat. § 19.84, the Election Inspectors will convene as a joint meeting of the Local Board of Canvassers and the Municipal Board of Canvassers for the purpose of conducting the local and municipal canvasses pursuant to Wis. Stat. §§7.51 and 7.53(1). This meeting will be open to the public pursuant to Wis. Stat. §§ 19.81-89.

OFFICE OF THE ST. CROIX COUNTY CLERK
TO THE VOTERS OF ST. CROIX COUNTY

Notice is hereby given of a spring election to be held in St. Croix County, on April 6, 2021, at which the officers named below shall be chosen. The names of the candidates for each office, whose nominations have been certified to or filed in this office, are given under the title of the office, each in its proper column, together with the questions submitted to a vote, for a referendum, if any, in the sample ballot below.

INFORMATION TO VOTERS

Upon entering the polling place, a voter shall state his or her name and address, show an acceptable form of photo identification and sign the poll book before being permitted to vote. If a voter does not have acceptable photo identification the voter may obtain a free photo ID for voting from the Division of Motor Vehicles. If a voter is not registered to vote, a voter may register to vote at the polling place serving his or her residence, if the voter presents proof of residence in a form specified by law. Where ballots are distributed to voters, the initials of two inspectors must appear on the ballot. Upon being permitted to vote, the voter shall retire alone to a voting booth and cast his or her ballot except that a voter who is a parent or guardian may be accompanied by the voter's minor child or minor ward. An election official may inform the voter of the proper manner for casting a vote, but the official may not in any manner advise or indicate a particular voting choice.

Where Optical Scan Voting Ballots are Used

The voter shall fill in the oval next to the name of the candidate of his or her choice for each office for which he or she intends to vote. To vote for a person whose name does not appear on the ballot, the voter shall write in the name of the person of his or her choice in the space provided for a write-in vote, and fill in the oval next to the write-in line. On referendum questions, the voter shall fill in the oval next to "yes" if in favor of the question, or the voter shall fill in the oval or connect the arrow next to "no" if opposed to the question.

When using an electronic ballot marking device ("ExpressVote") insert the activation card into the ExpressVote to mark a ballot. The voter shall then touch the screen next to the name of the candidate of his or her choice for each office for which he or she intends to vote. To vote for a person whose name does not appear on the ballot, the voter shall type in the name of the person of his or her choice in the space provided for a write-in vote. On referendum questions, the voter shall touch the screen at "yes" if in favor of the question, or the voter shall touch the screen at "no" if opposed to the question.

The vote should not be cast in any other manner. Not more than five minutes' time shall be allowed inside a voting booth. Sample ballots or other materials to assist the voter in marking his or her ballot may be taken into the booth and copied. The sample ballot shall not be shown to anyone so as to reveal how the ballot is marked.

If a voter spoils an **optical scan or ExpressVote ballot**, he or she shall return it to an election official who shall issue another ballot in its place, but not more than three ballots shall be issued to any one voter. If the ballot has not been initialed by two inspectors or is defective in any other way, the voter shall return it to the election official who shall issue a proper ballot in its place.

After Voting the Ballot

After an **official optical scan or ExpressVote** ballot is marked, it shall be inserted in the security sleeve so the marks do not show. The voter shall then insert the ballot in the voting device and discard the sleeve, or deliver the ballot to an inspector for deposit. The voter shall deposit the voted ballot in the ballot box or deliver the ballot to an inspector for deposit. The voter shall leave the polling place promptly.

A voter may select an individual to assist in casting his or her vote if the voter declares to the presiding official that he or she is unable to read, has difficulty reading, writing, or understanding English, or that due to disability is unable to cast his or her ballot. The selected individual rendering assistance may not be the voter's employer or an agent of that employer or an officer or agent of a labor organization which represents the voter.

NOTICE OF REFERENDUM--TOWN OF HUDSON

TO THE VOTERS IN THE TOWN OF HUDSON:

NOTICE IS HEREBY GIVEN, that at an election to be held in the Town of Hudson on Tuesday, April 6, 2021, the following resolution/question will be submitted to a vote of the people:

WHEREAS, a petition signed by at least 20 electors requesting adoption of the nonpartisan primary nomination process was filed with the Town of Hudson, St. Croix County, Wisconsin, on January 18, 2021.

LET IT BE RESOLVED that, pursuant to Wis. Stat. § 8.05(3)(d), the Town Board of Hudson does hereby place the following question on the ballot for the April 6, 2021 election: "Shall all candidates in the Town of Hudson for elective town offices be nominated at a nonpartisan primary?"

The question will appear on the ballot as follows: "Shall all candidates in the Town of Hudson for elective town offices be nominated at a nonpartisan primary?"

EXPLANATION

A petition requesting adoption of the nonpartisan primary nomination process for Town of Hudson elected officials was signed by at least 20 electors of the Town of Hudson and was filed with the Town Clerk on January 18, 2021. Pursuant to state law (Wis. Stat. § 8.05(3)(d)), the question of adoption of the nonpartisan primary must then be submitted to a vote of the people.

A **"YES" vote** means that elected officials for the Town of Hudson will no longer be nominated at a caucus and will instead be nominated at a nonpartisan primary.

A **"NO" vote** means that elected officials for the Town of Hudson will continue to be nominated at a caucus.

NOTICE OF REFERENDUM ELECTION--SCHOOL DISTRICT OF ST. CROIX CENTRAL

TO THE VOTERS IN THE ST. CROIX CENTRAL SCHOOL DISTRICT:

TAKE NOTICE that a referendum election shall be held on April 6, 2021 in the Saint Croix Central School District for the purpose of approving or rejecting a Revenue Cap Resolution and an Initial Resolution adopted by the School Board of said District on January 25, 2021.

The Revenue Cap Resolution reads as follows:

RESOLUTION TO EXCEED REVENUE CAP COMMENCING WITH THE 2021-22 SCHOOL YEAR

BE IT RESOLVED by the School Board of the Saint Croix Central School District, St. Croix County, Wisconsin, that the final school district budget shall include the amounts set forth below in excess of the revenue limits imposed by Section 121.91 of the Wisconsin Statutes on a recurring basis over a period of ten years commencing with the 2021-22 school year as follows: \$1,700,000 in the 2021-22 school year and \$350,000 in each of the 2022-23 through 2030-31 school years aggregating total recurring revenue cap relief of \$4,850,000 in the 2030-31 school year and thereafter for the purpose of paying the costs of maintaining competitive staff compensation and other District operating expenses.

The referendum ballot will ask District electors: "Shall the School Board of the Saint Croix Central School District be authorized to exceed the revenue limit under Section 121.91 of the Wisconsin Statutes on a recurring basis over a period of ten years commencing with the 2021-22 school year as follows: \$1,700,000 in the 2021-22 school year and \$350,000 in each of the 2022-23 through 2030-31 school years aggregating total recurring revenue cap relief of \$4,850,000 in the 2030-31 school year and thereafter for the purpose of paying the costs of maintaining competitive staff compensation and other District operating expenses as provided in the foregoing resolution?"

A "yes" vote is in favor of the resolution set forth above and is a vote to approve exceeding the revenue limit under Section 121.91 of the Wisconsin Statutes on a recurring basis over a period of ten years commencing with the 2021-22 school year as follows: \$1,700,000 in the 2021-22 school year and \$350,000 in each of the 2022-23 through 2030-31 school years aggregating total recurring revenue cap relief of \$4,850,000 in the 2030-31 school year and thereafter for the purpose of paying the costs of maintaining competitive staff compensation and other District operating expenses.

A "no" vote is opposed to the resolution and is a vote to deny exceeding the revenue limit under Section 121.91 of the Wisconsin Statutes on a recurring basis over a period of ten years commencing with the 2021-22 school year as follows: \$1,700,000 in the 2021-22 school year and \$350,000 in each of the 2022-23 through 2030-31 school years aggregating total recurring revenue cap relief of \$4,850,000 in the 2030-31 school year and thereafter for the purpose of paying the costs of maintaining competitive staff compensation and other District operating expenses.

The Initial Resolution reads as follows:

**INITIAL RESOLUTION AUTHORIZING ISSUANCE OF GENERAL OBLIGATION BONDS
IN AN AMOUNT NOT TO EXCEED \$22,500,000**

BE IT RESOLVED by the School Board of the Saint Croix Central School District, St. Croix County, Wisconsin, that there shall be issued, pursuant to Chapter 67, Wisconsin Statutes, General Obligation Bonds in an amount not to exceed \$22,500,000 for the purpose of paying the costs of improvements to the High School including a career and technical education addition, a classroom addition, classroom renovations, and related site improvements and equipment acquisition; constructing and equipping a K4 addition and related improvements at the Elementary School and acquisition of land adjacent to the Elementary School; and HVAC upgrades at all district school buildings.

The referendum ballot will ask District electors: "Shall the foregoing resolution of the School Board of the Saint Croix Central School District be approved?"

A "yes" vote is in favor of the Initial Resolution set forth above and is a vote to approve the borrowing of not to exceed \$22,500,000 by the Saint Croix Central School District through the issuance of General Obligation Bonds for the purpose of paying the costs of improvements to the High School including a career and technical education addition, a classroom addition, classroom renovations, and related site improvements and equipment acquisition; constructing and equipping a K4 addition and related improvements at the Elementary School and acquisition of land adjacent to the Elementary School; and HVAC upgrades at all district school buildings.

A "no" vote is opposed to the Initial Resolution and is a vote to deny the Saint Croix Central School District the authority to borrow not to exceed \$22,500,000 through the issuance of General Obligation Bonds for the purpose of paying the costs of improvements to the High School including a career and technical education addition, a classroom addition, classroom renovations, and related site improvements and equipment acquisition; constructing and equipping a K4 addition and related improvements at the Elementary School and acquisition of land adjacent to the Elementary School; and HVAC upgrades at all district school buildings.

WISCONSIN REQUIRES PHOTO ID TO VOTE!

ACCEPTABLE PHOTO IDs FOR VOTING IN WISCONSIN

The following photo IDs are acceptable for voting purposes, and can be unexpired or expired after, November 3, 2020 (currently the date of the last General Election):

- A Wisconsin DOT-issued driver license, even if driving privileges are revoked or suspended. Your Wisconsin
- DOT-issued driver license does not need to be REAL-ID compliant.
- A Wisconsin DOT-issued identification card. Your Wisconsin DOT-issued ID card does not need to be REALID compliant.
- Military ID card issued by the U.S. Uniformed Services
- A U.S. passport book or card

The following photo IDs are also acceptable for voting purposes:

- A certificate of naturalization (that was issued not earlier than two years before the date of the election)
- An identification card issued by a federally recognized Indian tribe in Wisconsin
- A driver license receipt issued by Wisconsin DOT (valid for 45 days from date issued)
- An identification card receipt issued by Wisconsin DOT (valid for 45 days from date issued)
- A Wisconsin DMV ID Petition Process Photo Receipt (valid for 60 days from date issued)
- A Veteran Affairs ID card (must be unexpired or have no expiration date)
- A photo identification card issued by a Wisconsin accredited university or college, or technical college that contains the following:
 - Date the card was issued
 - Signature of student
 - Expiration date no later than two years after date of issuance, can still be used if expired
 - If the student ID is expired, the university or college ID must be accompanied by a separate document that proves current enrollment, such as a tuition fee receipt, enrollment verification letter, or class schedule
