The St. Croix Valley Bar Association is hosting a Free Legal Clinic on January 21, 2026, from 6:00 p.m. – 7:30 p.m. The Free Legal Clinic will take place virtually, using Zoom.

Because the Clinic is taking place on Zoom, **you do not need to travel to the Courthouse to participate**. Instead, you can participate in the Free Legal Clinic by (1) standard telephone, (2) smartphone, or by (3) personal computer. The Clinic begins at 6:00 p.m. and ends at 7:30 p.m.

We will have a limited number of volunteer attorneys for this clinic. The attorneys on January 21, 2026, will **only** be able to assist in matters relating to: **landlord/tenant, small claims/civil litigation, and employment law**. If your legal issue does not fall within one of these categories, please attend another clinic at a later date.

Smartphone
