This meeting will be open to the public pursuant to Wis. Stat. §§ 19.81-89.

#### \*\*Notice of Meeting of the Local and Municipal Board of Canvassers

At the close of voting on Election Day, pursuant to the provisions of Wis. Stat. § 19.84, the Election Inspectors will convene as a joint meeting of the Local Board of Canvassers and the Municipal Board of Canvassers for the purpose of conducting the local and municipal canvasses pursuant to Wis. Stat. §§ 7.51 and 7.53(1). This meeting will be open to the public pursuant to Wis. Stat. §§ 19.81-89.

# OFFICE OF THE ST. CROIX COUNTY CLERK TO THE VOTERS OF ST. CROIX COUNTY

Notice is hereby given of a spring election to be held in St. Croix County, on Tuesday, April 1, 2025, at which the officers named below shall be chosen. The names of the candidates for each office to be voted for, whose nominations have been certified to or filed in this office, are listed under the title of the office and under the appropriate party or other designation, together with the questions submitted to a vote, for a referendum in the sample ballots below.

## INFORMATION TO VOTERS

Upon entering the polling place and before being permitted to vote, a voter shall:

- state their name and address
- show an acceptable form of photo identification\*
- sign the poll book\*\*

\*If a voter does not have acceptable photo identification, the voter may obtain a free photo ID for voting from the Division of Motor Vehicles.

\*\*If the voter is unable to sign the poll book due to disability, a poll worker may write the word "exempt."

If a voter is not registered to vote, they may register to vote at the polling place serving their residence if the voter provides proof of residence.

Where ballots are distributed to voters, the initials of two inspectors must appear on the ballot.

Upon being permitted to vote, the voter shall enter a voting booth or go to a machine and cast their ballot. The vote should not be cast in any manner other than specified here. Sample ballots or other materials to assist the voter in marking their ballot may be taken into the booth and copied. The sample ballot shall not be shown to anyone so as to reveal how the ballot is marked.

A voter who is a parent or guardian may be accompanied by the voter's minor child or minor ward.

An election official may inform the voter of the proper manner for casting a vote, but the official may not advise or indicate a particular voting choice.

## Assistance for Voting

A voter may select an individual to assist in casting their vote if the voter declares to the presiding official that they are unable to read, have difficulty reading, writing, or understanding English, or that due to disability are unable to cast their ballot. The selected individual rendering assistance may not be the voter's employer

or an agent of that employer or an officer or agent of a labor organization which represents the voter. If a voter is unable to state their name and address, an assistant may also do so for the voter.

## Where Optical Scan Voting is Used

The voter shall fill in the oval next to the name of the candidate of their choice for each office for which they intend to vote. To vote for a person whose name does not appear on the ballot, the voter shall write in the name of the person of their choice in the space provided for a write-in vote and fill in the oval next to the write-in line. On referendum questions, the voter shall fill in the oval next to "yes" if in favor of the question, or the voter shall fill in "no" if opposed to the question.

When using an *electronic ballot marking device* ("ExpressVote") to mark an **optical scan ballot**, the voter shall touch the screen to select the name of the candidate of their choice for each office for which they intend to vote. To vote for a person whose name does not appear on the ballot, the voter shall touch the screen next to "write-in" and type in the name of the person of their choice. On referendum questions, the voter shall touch the screen or use the tactile pad to select "yes" if in favor of the question, or the voter shall touch the screen or use the tactile pad to select "no" if opposed to the question.

## Spoiling Ballots

If a voter spoils an **optical scan ballot**, they shall return it to an election official who shall issue another ballot in its place, but not more than three ballots shall be issued to any one voter. If the ballot has not been initialed by two inspectors or is defective in any other way, the voter shall return it to the election official who shall issue a proper ballot in its place.

The voter may spoil a **touch screen** (ExpressVote) ballot at the voting station before the ballot is cast.

## After Voting the Ballot

After an official **optical scan ballot** is marked, it may be inserted in a security sleeve, so the marks do not show. The voter shall then insert the ballot in the voting device or deliver the ballot to an inspector for deposit. The voter shall leave the polling place promptly.

After an official **touch screen ballot** is cast, the voter shall leave the polling place promptly.

**All St. Croix County residents will be voting on a ballot similar to the SAMPLE ballots which includes the offices of State Superintendent of Public Instruction, Justice of the Supreme Court, Court of Appeals Judge District 3, St. Croix County Circuit Court Judge Branch 2 and a statewide referendum. Municipal, school board and other local referenda will be unique to your residence.**

Notice to voters: If you are voting on Election Day, your ballot must be initialed by two (2) election inspectors. If you are voting absentee, your ballot must be initialed by the municipal clerk or deputy clerk. Your ballot may not be counted without initials (see end of ballot for sample).

**General Instructions**

If you make a mistake on your ballot or have a question, ask an election inspector for assistance. If you are unable to read, write, or understand English, contact your municipal clerk.

To vote for a name on the ballot, fill in the oval next to the name of the office. To vote for a name that is not on the ballot, write the name on the line marked "write-in" and fill in the oval next to the line.



# REFERENDA

## STATEWIDE REFERENDUM

NOTICE IS HEREBY GIVEN, that at an election to be held in the several towns, villages, wards, and election districts of the State of Wisconsin, on Tuesday, April 1, 2025, the following question will be submitted to a vote of the people pursuant to law:

### 2025 SENATE JOINT RESOLUTION 2

**To create** section 1m of article III of the constitution; **relating to:** requiring photographic identification to vote in any election (second consideration).

Whereas, the 2023 legislature in regular session considered a proposed amendment to the constitution in 2023 Senate Joint Resolution 73, which became 2023 Enrolled Joint Resolution 9, and agreed to it by a majority of the members elected to each of the two houses, which proposed amendment reads as follows:

#### SECTION 1. Section 1m of article III of the constitution is created to read:

[Article III] Section 1m (1) No qualified elector may cast a ballot in any election unless the elector presents valid photographic identification that verifies the elector's identity and that is issued by this state, the federal government, a federally recognized American Indian tribe or band in this state, or a college or university in this state. The legislature shall by law establish acceptable forms of photographic identification, and the legislature may by law establish exceptions to the requirement under this subsection.

(2) A qualified elector who is unable to present valid photographic identification on election day shall be permitted to cast a provisional ballot. A provisional ballot may not be counted unless the elector presents valid photographic identification at a later time and place as provided by the legislature by law.

**SECTION 2. Numbering of new provision.** If another constitutional amendment ratified by the people creates the number of any provision created in this joint resolution, the chief of the legislative reference bureau shall determine the sequencing and the numbering of the provisions whose numbers conflict.

**Now, therefore, be it resolved by the senate, the assembly concurring, That** the foregoing proposed amendment to the constitution is agreed to by the 2025 legislature; and, be it further

**Resolved, That** the foregoing proposed amendment to the constitution be submitted to a vote of the people at the election to be held on the first Tuesday of April 2025; and, be it further

**Resolved, That** the questions concerning ratification of the foregoing proposed amendment to the constitution be stated on the ballot as follows:

**QUESTION 1: "Photographic identification for voting.** Shall section 1m of article III of the constitution be created to require that voters present valid photographic identification verifying their identity in order to vote in any election, subject to exceptions which may be established by law?"

#### EXPLANATORY STATEMENT AS TO THE QUESTION

The Wisconsin Constitution provides that "only a United States citizen age 18 or older who is a resident of an election district in this state is a qualified elector of that district who may vote in an election for national, state, or local office or at a statewide or local referendum." Wis. Const. art. III, § 2. The referendum question would add a new provision to Wis. Const. art. III to require that voters present valid photographic identification to exercise their rights as electors.

The proposed constitutional text would provide that acceptable photographic identification must be "issued by this state, the federal government, a federally recognized American Indian tribe or band in this state, or a college or university in this state." The proposal therefore would exclude identification such as out-of-state driver's licenses and tribal identification issued by non-Wisconsin tribes.

The proposal would allow, but not require, the legislature to create exceptions to the identification requirement. Courts have held that some exceptions are

required by the U.S. Constitution. The proposal would also prevent future legislatures from repealing statutory photographic identification requirements altogether.

A "yes" vote would vote to create a new article III, section 1m of the Wisconsin Constitution to require voters to present "valid photographic identification" in order to vote.

A "no" vote would vote not to create the new constitutional provision.

The referendum ballot will ask District electors: "Shall the School Board of the School District of Hudson be authorized to exceed the revenue limit under Section 121.91 of the Wisconsin Statutes beginning with the 2025-26 school year through the 2030-31 school year on a non-recurring basis by an amount of not to exceed \$5,000,000 each year for the purpose of paying District operation, maintenance and staffing costs as provided in the foregoing resolution?"

#### Explanation

A "yes" vote is in favor of the resolution set forth above and is a vote to approve exceeding the revenue limit under Section 121.91 of the Wisconsin Statutes for the 2025-26 through 2030-31 school years on a non-recurring basis by an amount of not to exceed \$5,000,000 each year for the purpose of paying District operation, maintenance and staffing costs.

A "no" vote is opposed to the resolution and is a vote to deny exceeding the revenue limit under Section 121.91 of the Wisconsin Statutes for the 2025-26 through 2030-31 school years on a non-recurring basis by an amount of not to exceed \$5,000,000 each year for the purpose of paying District operation, maintenance and staffing costs.

#### **QUESTION NUMBER II**

"Shall the School District of Spring Valley, Pierce, St. Croix and Dunn Counties, Wisconsin be authorized to issue pursuant to Chapter 67 of the Wisconsin Statutes, general obligation bonds in an amount not to exceed \$3,350,000 for the public purpose of paying the cost of a school building and facility improvement project consisting of: construction of a track and field facility and site improvements at the Middle/High School campus; swimming pool improvements; related safety, security and accessibility improvements; and acquisition of furnishings, fixtures and equipment?"

#### **Explanation**

The referendum election ballot will ask District electors to vote "yes" or "no" on the referendum election questions as set forth above.

A "yes" vote on Question Number I is a vote to approve the borrowing of \$9,800,000 by the School District of Spring Valley through the issuance of general obligation bonds for the purpose of paying the cost of a school building and facility improvement project consisting of: remodeling and capital maintenance improvements at the Middle/High School; district-wide infrastructure, safety, security, accessibility and site improvements; construction of a transportation building; and acquisition of furnishings, fixtures and equipment.

A "no" vote on Question Number I is a vote to deny the School District of Spring Valley the authority to borrow \$9,800,000 through the issuance of general obligation bonds for the purpose of paying the cost of a school building and facility improvement project consisting of: remodeling and capital maintenance improvements at the Middle/High School; district-wide infrastructure, safety, security, accessibility and site improvements; construction of a transportation building; and acquisition of furnishings, fixtures and equipment.

In the event a majority of the electors voting on Question Number I vote "yes", the District will be authorized to undertake the school building and facility improvement program described in Question Number I and borrow not in excess of \$9,800,000 therefor; if a majority vote "no" on Question Number I set forth above, the District will not be so authorized.

A "yes" vote on Question Number II is a vote to approve the borrowing of \$3,350,000 by the School District of Spring Valley through the issuance of general obligation bonds for the purpose of paying the cost of a school building and facility improvement project consisting of: construction of a track and field facility and site improvements at the Middle/High School campus; swimming pool improvements; related safety, security and accessibility improvements; and acquisition of furnishings, fixtures and equipment.

A "no" vote on Question Number II is a vote to deny the School District of Spring Valley the authority to borrow \$3,350,000 through the issuance of general obligation bonds for the purpose of paying the cost of a school building and facility improvement project consisting of: construction of a track and field facility and site improvements at the Middle/High School campus; swimming pool improvements; related safety, security and accessibility improvements; and acquisition of furnishings, fixtures and equipment.

In the event a majority of the electors voting on Question Number II vote "yes", the District will be authorized to undertake the school building and facility improvement program described in Question Number II and borrow not in excess of \$3,350,000 therefor; if a majority vote "no" on Question Number II set forth above, the District will not be so authorized.

# WISCONSIN REQUIRES PHOTO IDS TO VOTE!

## ACCEPTABLE PHOTO IDS FOR VOTING IN WISCONSIN

**The following photo IDs are acceptable for voting purposes, and can be unexpired or expired after, November 5, 2024 (currently the date of the last General Election):**

- A Wisconsin DOT-issued driver license, even if driving privileges are revoked or suspended. Your Wisconsin DOT-issued driver license does not need to be a "REAL ID".
- A Wisconsin DOT-issued identification card. Your Wisconsin DOT-issued ID card does not need to be a "REAL ID".
- Military ID card issued by the U.S. Uniformed Services
- A U.S. passport book or card

**The following photo IDs are also acceptable for voting purposes:**

- A certificate of naturalization (that was issued not earlier than two years before the date of the election)
- An identification card issued by a federally recognized Indian tribe in Wisconsin
- A driver license receipt issued by Wisconsin DOT (valid for 45 days from date issued)
- An identification card receipt issued by Wisconsin DOT (valid for 45 days from date issued)
- A Wisconsin DMV ID Petition Process Photo Receipt (valid for 180 days from date issued)
- A Veteran Affairs ID card (must be unexpired or have no expiration date)
- A photo identification card issued by a Wisconsin accredited university or college, or technical college that contains the following:
  - Date the card was issued
  - Signature of student
  - Expiration date no later than two years after date of issuance, can still be used if expired
  - The university or college ID must be accompanied by a separate document that proves enrollment, such as a tuition fee receipt, enrollment verification letter, or class schedule

## VOTER ELIGIBILITY

**You must be 18 years of age to vote.** All voters in Wisconsin must be at least 18 years of age on the day of the election to be eligible to vote. Persons who are otherwise eligible to vote may register to vote at 17 years of age if they will be 18 by the next election.

**You must be a U.S. citizen in order to vote.** Citizenship is documented through a U.S. birth certificate or a Certificate of Naturalization, but proof of citizenship is not required to vote. Green card or visa status does not qualify a person to vote in Wisconsin elections.

**You must reside at your current address for at least 28 days prior to the election.** (You may register to vote as long as you will meet the 28-day requirement by the day of the election.)

If you have moved to a new address within Wisconsin within 28 days of an election, you may be qualified to vote from your former address until you meet the 28-day requirement at your new address.

If you have moved to Wisconsin from another state less than 28 days before an election, you are only eligible to vote for President and Vice-President in Wisconsin until you achieve the 28 days.
